Rules and Regulations

1. Service Club reserves the right to reject any application for exhibit space without prejudice and no contract for any one Antique Show establishes the right for any Exhibitor to have space in any future Show.
2. All merchandise should be antique or collectible and prices clearly marked.
3. ALL DEPOSITS ARE NON-REFUNDABLE AND NON-TRANSFERABLE.
4. Show Hours: Friday, February 26, 2010, 5:00 – 9:00 pm; Saturday, February 27, 2010, 10:00 am – 5:00 pm; Sunday, February 28, 2010, 11:00 am – 4:00 pm.
5. Set-up day is Friday, February 26, 2010 after 8:00 am. BOOTH WILL BE HELD ONLY UNTIL NOON ON SET-UP DAY UNLESS PRIOR ARRANGEMENTS HAVE BEEN MADE WITH MANAGEMENT.
6. All Exhibitors must vacate the building by 8:00 pm on Sunday, February 28, 2010.
7. No early departures except at close of each day. NO packing prior to 4:00 pm on Sunday.
8. Price of booth includes the number of tables indicated in the contract. Extra tables are available at the charge of \$15.00 per table and must be requested prior to February 1, 2010. IF YOU FAIL TO ASK FOR EXTRA TABLES, NONE WILL BE AVAILABLE AT SET-UP. If you do not need tables, please indicate this on application. Electricity is available at fee of \$30.00. WATTAGE IS LIMITED TO 400 WATTS PER BOOTH – PLEASE USE 75 WATT BULBS IN LAMPS. Wattage requirements over 400 watts will be charged at the rate of \$10.00 per 400 watts or fraction thereof.
9. Sharing of booths must be approved by Service Club prior to Show.
10. Exhibitor agrees to supply extension cords, lamps, double sockets, shelving, and insurance.
11. All tables must be covered and skirting to the floor, coverings and skirting to be supplied by Exhibitor.
12. Exhibitor agrees to take care of building with respect to floors and walls. NO NAILS ALLOWED IN FLOORS OR WALLS. NO PINS ON DRAPES.
13. All Fire Regulations must be observed. No smoking allowed in building.
14. Exhibitor agrees to leave booth free of trash at the end of each day.
15. Exhibitor agrees to abide by "NO PARKING" and "FIRE LANE" regulations, and all other regulations of the Manatee Convention Center. All Exhibitors must park in designated parking lots. NO EXCEPTIONS WILL BE MADE REGARDING PARKING.
16. No electric fans or heaters are permitted in booths.
17. No pets allowed.
18. A \$25.00 Service Charge will apply to all checks returned for insufficient funds.
19. SERVICE CLUB WILL PROVIDE NO INSURANCE. All Insurance must be placed and paid for by the Exhibitor. I/WE HEREBY RELIEVE THE BUILDING AND SERVICE CLUB OF ALL RESPONSIBILITY IN CONNECTION WITH THE SAFEKEEPING OF OUR PROPERTY WHILE SAID PROPERTIES ARE AT THE SHOW.
20. Neither Manatee Convention Center, Manatee County, Service Club, nor the Promoter shall be responsible for any injury or loss, or damage that may occur to Exhibitor or his employees or his merchandise from any cause while premises are being occupied under this contract.
21. If any casualty should arise making it impossible to have the Antique Show and Sale, Exhibitor waives any claim for damages. In such event, Service Club shall return all deposits.
